1, Samsung has crafted a very clever and obscene Gold Digger, Julie, for a long time and provided her to powerful prosecutors for lobbying purposes.

Korean First Lady Gold Digger "Julie", whose real name is Kim Myung-sin 金命新, changed her name to Kim Gun-hee after the late Samsung chairman Lee Gun-hee, the richest man in South Korea, in order to cover up her past as a bar hostess when she married the famous prosecutor General Yoon Seok-yeol.

Julie gained power as First Lady and began to raid and prosecute citizens who tried to dig up her pasts in all sorts of vicious ways, which was a process that exposed the shameful depths of the country called Korea and suppressed its good citizens for years.

The outrageous scandal that Gold Digger "Julie" created in Korean society is a good example of the geopolitical uniqueness of Korea as a country in the Far East, and also a good example of the deep-rooted ills of modern materialistic society.

Julie, one of the ugliest and most bizarre Gold Diggers in human history, is the department store of evil in a short-lived capitalist country like Korea.

This dirty and obscene scandal is so vicious that it has been called "the devil's play" for revealing the filthy depths of modern society armed with nationalist capitalism.

The reason her bar hostess nickname was "Julie" is said to be that she worked in the basement bar of a hotel run by a wealthy chairman who loved her, and she especially loved jewelry so she was called "Julie," which has a similar pronunciation to the English "jewelry ."

A female prosecutor was charged with defamation after she mocked Julie's corruption and antics by saying, "I wonder if Julie even knows how to spell English properly."

The person who introduced Julie, a bar hostess, to his college juniors, two promising chief prosecutors from Seoul Law School was the vice president of the pro-Japanese association, Cho Nam-wook, who also graduated from Seoul Law School, and the company which provided them with a place for their romantic affair was Samsung.

In Japan, in a special system called the "chaebol" 財閥 which was created to run large global corporations, there was even an open rumor that "the "chaebol" 財閥 manages the concubines of the chief prosecutors," and they used devilish methods to control the judiciary by interfering in the private lives of judges and women.

Samsung has been managing judges and prosecutors on a large scale at the group level and reaping profits.

Cho Nam-wook was the owner of the hotel where the nightclub Julie worked was located and was suspected that the one who gave Julie special favors, such as professor's job at Kookmin Univ. However, the witnesses who said Cho frequently called "Julie" to his room withdrew their testimony when the prosecutors' office started to question them.

(Construction company owner Cho Nam-wook and Prosecutor General Yoon Seok-yeol. Julie, the Gold digger, and her Fraudster Mother Choi Eun-soon.)



The chief prosecutors who lived together with Julie in different apartments of luxury Acrovista mansion provided by Samsung are Yang Jae-taek and Yoon Seok-yeol, who later became the president of south Korea. Julie's occupation is not only a college professor and hostess at night club, but also an art curator at later time.

Given that the person who strongly suggested that Yoon run for president was Samsung Chairman Lee Jae-yong's maternal uncle, it is believed that Samsung is the main body of the group that planned to gain political advantage by providing Julie with an apartment.



(Hong Seok-hyun, the uncle of the Samsung chairman, went with a physiognomist to Prosecutor General Yoon Seok-yeol and asked him to run for president.)

Considering that the group who helped her build her curatorial career is largely Japanese , it is possible that Cho Nam-wook, the vice president of the pro-Japanese association, and Japanese nationalist groups have invested in Julie for a long time for the sake of the major projects of the **Nippon club**. (Nippon Club is a tentative name for a group of pro-Japanese forces in Japan and Korea that serve the interests of Japan.)

There were media reports that when Julie was a college student, she started going out to bars after class with heavy makeup on her face.

Julie later married a hospital doctor, and it was reported that infidelity was the reason for her divorce from her first marriage.

(According to testimony from the Taekwondo master who was charged with defamation for witnessing Julie engaging in prostitution, the partner who slept with Julie said that Julie kept making sexual demands all night and that he could not sleep properly.)



It is speculated that the phenomenon of former prostitute First Lady Julie's sexual perversion was due to her innate sexual desire as well as the loss of her father at an early age, which she used to relieve through sex.

Cho Nam-wook, the owner of the Renaissance Hotel, who is older than Julie's late father, was the chairman of a construction company and was reported in the media as the person who introduced Julie, a bar hostess, to Yang Jae-taek and Yoon Seok-yeol, his juniors from Seoul Law School and renowned prosecutors.

It seems likely that Cho Nam-wook introduced Julie, a Gold Digger, to Yang Jae-taek, a married man, and Yoon Seok-yeol, a bachelor, as a bribe, and it appears that Cho Nam-wook, a businessman, attempted to gain vested interests by exploiting this special relationship with elite prosecutors who were his juniors at Seoul Law School.

Cho Nam-wook was also the vice president of the [Korea-Japan Friendship Promotion Association](#), and the pro-Japanese faction and right-wing forces in Japan are considered to be the forces that led the operation to maximize their vested interests and conspiracies for their own benefit on the Korean Peninsula.

For a time, Japan's conglomerates, which are sophisticated in conspiracy and trickery, had a special management style that was commonplace in Japan : managing the concubines of chief prosecutors as a means of protecting their own corruption.

The reason why it is believed that the Gold Digger Julie was created as a result of a long-standing conspiracy between the extreme right-wing forces in Japan, tentatively called the ["Nippon Club,"](#) to block inter-Korean cooperation between South Korea and pro-Japanese forces in Korea is because Julie's career as an art curator was created with the help of Japan for quite some time.

The reason why the host of the ["Nippon Club"](#) is presumed to be Samsung is because the late former Samsung Chairman Lee Gun-hee was suspected of having a Japanese mother, went to school in Japan and has considerable influence in Japan, and is a big shot at the Japanese Soka Gakkai 創価学会, as well as having the background and financial power to unite such forces.

Given that it was Samsung that provided Julie, Yoon Seok-yeol, and another prosecutor, Yang Jae-taek, with a love nest in the luxurious mansion "Acrovista," there is sufficient evidence to suggest that Julie's project was planned by the executives of Samsung, the host of the ["Nippon Club."](#)

(The luxurious mansion Acrovista, which Samsung provided as a love nest for Yoon Seok-yeol and Julie, was a bribe to influential prosecutors.)



While serving as the Chief Prosecutor and Prosecutor General, Yoon Seok-yeol framed an innocent citizen for imprisonment in an attempt to cover up the corruption of Julie and her mother, sentencing him to two years in prison and completely ruining his life Julie, who took the name of the late Samsung Chairman Lee Gun-hee and changed her identity to Kim Gun-hee, committed various fraudulent crimes to make money.

But instead, the victims were subjected to absurd searches and seizures and were punished, making them the criminals.

If the one who initiated these evil Julie's crimes and evil deeds was the conglomerate Samsung, then isn't Samsung a truly evil corporation ?

Impeached President Yoon Seok-yeol was a prosecutor with such a vicious personality that, while interrogating a female suspect, he would prevent her from going to the bathroom and even made her lay down newspapers in the interrogation room to urinate on them.

In addition to the routine court and prosecutorial lobbying, Samsung also has many legal tasks to get through in Korea, such as high inheritance taxes on the inheritance of new CEO Lee Jae-yong's assets, etc. etc.

In the past, Korean conglomerates used to collect illegal election funds to ensure the victory of the conservative party, put them in a car, and deliver the entire car.

It is presumed that they have been holding organized meetings for a few decades to secure the political power of the party they support.

Looking at the situation over the past 20 to 30 years, it seems that the "Nippon Club" has been formed and is either learning or imitating the techniques used by the Japanese nationalist Party to carry out one-sided politics.

Samsung has its own media power, Hyundai has its own newspaper, and even Moonie's Unification Church has its own newspaper, and the traditional pro-Japanese media conglomerates "Chosun daily news" and "Dong-A daily news" are leading them, and they have been moving to take over even TVs.

They seem to believe that if they take control of the prosecutors' office, they can completely take control of Korea, and it looks like they started to use gold digger strategy against the chief prosecutors based on this idea.

Media reporters who exposed such corruptions and conspiracies of the elite in such detail had their homes and businesses searched and seized by the police, or were prosecuted.

(Kookmin University is a trash university that bribed a prostitute, Julie, with a doctorate and a professorship. The level of university management in Korea is this much trashy. For example, twenty years ago, 200 fraudulent professors were found and indicted for publishing fraudulent books by putting their names in other people's books.)

Lee Jae-myung, a former presidential candidate, was reported to have erased a dot on his pepper to erase evidence of an affair that was exposed by an actress.

Lee lost the election because he volunteered as a free lawyer for an actress's lawsuit and enjoyed a free affair for over a year, and is now facing a prison sentence of around 10 years for various corruption and crimes.

(Thug Lee Jae-myung announced the diagnosis that there were no spots or surgical marks on the pepper pointed out by the actress, after an investigation conducted in just 7 minutes at a hospital next to the Gyeonggi Provincial Office where he is the governor. However, Jae-myung's announcement of the diagnosis after a visual examination that took only 7 minutes, when even a tissue biopsy alone requires considerable time, is another criminal fabrication.)

2, Samsung learned Japan's "evil management conspiracy tricks."

Korean conglomerates learned from Japan the unique capitalist governance structure in which a special group called the "chaebol" 財閥 cleverly controls and manages multiple companies with limited amounts of wealth.

The conglomerates not only maintained a system that monopolized management and developed their companies into large corporations, but they also learned from Japanese practices such as tax evasion, smuggling, buying politicians, manipulating stocks, lobbying judges in the judiciary, and using the media to control public opinion, which led to their great success in Korea.



(Samsung founder Lee Byung-chul, his son Lee Gun-hee, whose mother is suspected of being Japanese and who made Samsung into a global conglomerate, and current Samsung CEO Lee Jae-yong.)

Dong-A Daily News, a major newspaper in Korea, was a righteous media outlet that was respected in society for exposing Samsung's antisocial and bizarre evil deeds, and it even maintained a "war relationship" with Samsung for a considerable period of time by serializing Samsung's evil deeds.

Articles I read over 50 years ago that I still remember today include one about Samsung bribing gold-plated golf clubs to government officials in order to influence them, and another about Samsung's outrageous evil deeds, such as digging up all but the owner's land with an excavator and turning the surrounding area into a cliff when the owner refused to sell the land they should buy to build buildings or factories.

The poor relationship between Samsung and Dong-A Daily News during the tenure of Chairman Lee Byung-chul changed 180 degrees to an alliance under his son, Chairman Lee Gun-hee. This in-law alliance was formed when Lee Gun-hee's daughter and the divorced son of the Dong-A Ilbo chairman married dramatically. If this marriage was for political gain, then Samsung Chairman Lee Gun-hee is indeed an incredible businessman.

Since this marriage, the Dong-A Ilbo has transformed into a Samsung PR media outlet, and it is almost impossible to run a media outlet without advertising revenue from the Samsung conglomerate, which owns numerous companies in Korea.

(Husband Kim Jae-yeol, president of Dong-A Daily news, and his wife, a second daughter of Lee Gun-hee, the eldest daughter of Lee Gun-hee, and the son of Lee Gun-hee, the current CEO of Samsung, Lee Jae-yong.

The youngest daughter committed suicide after failing to have a relationship with an ordinary man, whom she was not allowed to date according to Samsung's rules.)



Chaebols, which take small stakes in companies and then gather many firms to control them as a whole through the combined power created, are also one of the great secrets of short-term economic growth in Japan and Korea.

To achieve these personal goals outside the law, they must maintain special and secret relationships with government bureaucrats and politicians, as well as extremely special and secret connections with judges and prosecutors in the courts and prosecutions.

Because Samsung's influence in lobbying the judiciary was almost absolute, Samsung's chairman was acquitted in most trials, and even those who were found guilty were later pardoned by politicians.

(Attorney Kim Yong-cheol, a former member of the Samsung legal team, accused Samsung of systematically lobbying the judiciary and politicians on a large scale while operating its legal team, committing corruption, creating slush funds, and tainting Korea with corruption. It was revealed that a significant number of public officials had been receiving bribes in a sophisticated manner from all walks of life and professional fields. The reason why Attorney Kim is surrounded by priests and holding a press conference to make his accusation is because he wants to get help from priests, a group that has fought corruption with their knees crossed.)



3, Did Samsung gift a "not guilty verdict" to the next president, Lee Jae-myung?



The prevailing opinion in Korean society is that the reason Lee Jae-myung, who was almost disqualified from running for president, was able to run for president and win dramatically was because Samsung helped with the trial, resulting in an acquittal.

Lee Jae-myung, the leader of the Democratic Party and the strongest presidential candidate, has a history of ugly corruption, crime, hypocrisy, and adultery, enough to be called a "national representative thug."

Just as thug Trump, who was sentenced to prison for breach of trust, was elected president with the help of the court, Democratic Party leader Lee Jae-myung's chances of being elected president were rekindled ten days ago with an acquittal, the court's second trial decision is quite interesting as it is truly a bizarre ruling.

The first trial verdict, which denied knowing the public official close to Lee Jae-myung who committed suicide due to corruption, was one year in prison and two years of probation.

Lee Jae-myung met with Samsung Chairman Lee Jae-yong six days before being acquitted in the second trial.

My guess about the absurd not-guilty verdict and the meeting with the Samsung Chairman is as follows. Traditionally, Samsung has not supported the left-leaning Democratic Party and has been keen to sabotage Democratic Party politics, but this time, the situation for Samsung and its chairman is quite different.

Samsung has long been revealed to have followed the practices of Japanese conglomerates and played the role of a detailed whore madam who connected the prostitute First lady Julie

and the impeached President Yoon.

Despite Samsung's efforts, it was President Yoon's prosecution that arrested the Samsung chairman on bribery charges and repeatedly appealed the first and second trials to the high court and the Supreme Court, so Samsung naturally harbors considerable resentment toward impeached former President Yoon.

From the perspective of the Samsung chairman, he needs a faithful hunting dog that will take revenge on the ungrateful President Yoon and his uncle, the owner of the media that exposed corruption against him, and he needs a thug president who will firmly support the future of Samsung. In this whole situation, the possibility of gifting a "not guilty verdict" to Democratic Party leader Lee Jae-myung is very high.

There is also a possibility that Lee Jae-myung went to Samsung, which has strong lobbying power in the courts, gave them a blank check, and knelt down and swore that if they spared him this time, he would do anything for them in the future.

Samsung is notorious not only for its political circles but also for its vicious lobbying of the judiciary.

Before Samsung became what it is today, there were countless corruption crimes, strange trials, and not-guilty verdicts, as well as the sacrifices of a considerable number of quite many innocent citizens.

It is highly possible that Samsung could have lobbied the judges to easily acquit and release Lee Jae-myung, the Democratic Party's criminal thug representative who should have to go to prison for about 10 years due to multiple trials, and turn Lee Jae-myung into a loyal hunting dog that Samsung can use in the future.

This very economical food culture of eating loyal dogs after hunting season is a long-standing traditional custom among Koreans, Chinese, and Asians. (兔死狗烹)

It is an undeniable, definite fact that most of the former presidents were sacrificed as prey to this kind of cruel Korean food culture of eating clever street dogs.

They were momentarily deluded into thinking they had become the victors of the materialistic world but eventually suffered the tragedy of being buried en masse in the pit of the wicked.

Ahead of the second trial, thug Lee Jae-myung met with Samsung Chairman Lee Jae-yong and flattered Samsung until his mouth dried up. This is a direct contradiction to his past claims that the conglomerates like Samsung should be dismantled for social Justice.

Lee Jae-myung insisted on abolishing the law requiring the National Assembly's vote in order to arrest a member of the National Assembly, thereby abolishing the privilege of immunity from arrest.

Lee Jae-myung, who completely contradicted his own words, incited the Democratic Party to

make the arrest impossible when an arrest warrant was requested for him.

Lee Jae-myung is a miserable swindler thug dog who changes his words and lies whenever necessary, and 175 congressmen who follow him are no more than street thugs who can do anything to make a living.

Lee Jae-myung has been fully approved as a representative of the country's thug style who uses all kinds of dirty methods for money and promotion, regardless of the means and methods.

His father was a conman who was addicted to gambling and ran away with the money the villagers earned from selling agricultural products for a year as the head of the cooperative. His nephew was a vicious criminal who stabbed his girlfriend and her mother to death dozens of times with a knife.

Korea is not so corrupt as to entrust the presidency to this evil family, and I, along with all the citizens, will demand that the Supreme Court justices, my long-time subscribers, immediately revoke his right to run for the election.

I believe that the Supreme Court justices would never want such a disaster, because it is so obvious that if the thug Lee Jae-myung and the thug Democratic Party are given power, Korea will become a republic of thugs in no time.

It is speculated that one of the reasons for the divorce is that his wife's father was arrested for breach of trust, but Samsung's powerful lobbying power in the courts did not prevent the imprisonment.)



Five consecutive Korean presidents who have continued to commit evil acts such as sexual scandal, corruption, and bribery, thereby destroying national order completely and harassing the people.

Lee Jae-myung, the newly elected thug president, is a dirty fraud who was elected through unfair means.

The impeached president, Yoon Seok-yeol, is a human being who was created through a long-term conspiracy between Japan, pro-Japanese forces in Korea, and Samsung, and he is a suspect in several abuse of power crimes after marrying "Julie," a fraud suspect gold-digger. The reason why Yoon was chosen by the vicious pro-Japanese right-wing forces in Korea and given Julie, a professional gold-digger they had nurtured for many years, to Yoon is because of the Japanese conglomerates' tactic of "managing the concubine of the chief prosecutor to cover up their corruption and prevent future troubles."

Samsung's persistent lobbying of the courts and prosecutors is so vicious that it has given Korea the nickname "Samsung Republic" and led to the publication of a book that delves into it.

Yoon Seok-yeol is such a simple and cruel person that there was even a book published accusing him of harassing a female suspect in the past by not allowing her to go to the bathroom while interrogating her, resulting in the suspect urinating on a newspaper.

However, if Yoon is impeached, there is a strong possibility that Lee Jae-myung, the leader of the Democratic Party who is even more cunning and dirty than a shit puppy, has become the president of Korea, putting Korea in even greater danger.

According to the testimony of an erotic actress who is famous for having had an affair with Lee for over a year, Lee approached her with the offer of free legal representation when he was a lawyer, and when the actress found out about Lee Jae-myung's bad personality and suggested breaking up, he threatened her.



Lee Jae-myung is such a dirty and ugly thug that he swore at his sister-in-law, saying he would rip her genitals off, tried to forcibly admit his older brother to a mental hospital for abuse of power when he was mayor, and threatened an actress that she could be arrested for past drug use.

The person who managed the nomination of 175 Democratic Party members to turn them into a private party for the dirty puppy Lee Jae-myung is Lim Hyeok-baek, a professor of political science at Korea University.

The most serious problem in modern society is the fact that famous intellectuals, like Lim Hyeok-baek, sell their knowledge for money like prostitution.

Lee is on trial for several fraud cases, and if he succeeds in inciting the Korean people to impeach the current president,

Yoon Seok-yeol, he could create chaos similar to when the evil Trump incited refusal to accept the election results.

7, Systematic Securities Manipulation by Samsung and conglomerate (chaebols) Securities and Japan's Intervention.

On July 9, 1999, the highest day for the composite stock price, a breaking news article appeared on the bulletin boards of each securities company: "Nomura in Japan set the year-end target price for Samsung Electrical Display (now Samsung SDI), which was at a high of 78,000 won at the time, at a whopping 129,000 won."

With a huge amount of buying, the stock soon reached its highest price of the year, approaching the upper limit.

The very next day, large conglomerate securities firms, seeing that they could make a profit, all turned to selling in large quantities, causing the stock price to continue to fall, and the last stock price of Samsung SDI in 1999 fell to the miserable 40,000 won range.

This is judged to be an operation close to a **"Perfect Crime of manipulation."**

First, since it is information from a foreign organization in a neighboring country, domestic investment institutions are not responsible for the source of the operation information. Nomura Securities can also avoid responsibility by saying that it is only an expected price. However, regarding the stock price that is drawing a steep downward line at the crossroads of moving from CRT to TFT (in fact, foreign investment institutions are selling Samsung Electrical Display on a large scale around this time), the securities company's breaking news that Japan's Nomura is selling its name and setting a target price that is a whopping 60 percent higher than the stock price at the time will require Japan's Nomura to fully explain the background of the suspicion of intentional criminality.

Nomura Securities is an organization that provides massive funds to the **Nippon Foundation**, an extreme right-wing group established by Ryoichi Sasaki, a first-class war criminal of the Japanese Pacific War. Ryoichi Sasaki's Japan Foundation is an organization that has been allied with pro-Japanese forces in Korea and has been hindering cooperation between Korea and North Korea, which is the biggest concern for Japan. It is very likely that the stock price manipulation incident of Samsung Korea was possible at the request of pro-Japanese forces in Korea, and Nomura Securities, the sponsor of the Sasaki Foundation, was able to do so.

Isn't this the case of the Japan Foundation, a far-right Japanese organization that has poured a lot of money into Korea, has been working to sabotage inter-Korean cooperation and gather pro-Japanese forces in Korea, helping manipulate the stock price of Samsung in Korea and showing off advanced countries' stock price manipulation techniques to pro-Japanese forces by proving, "If you cooperate with us, you will benefit."

Korea was destined to become an extreme victim of similar crimes, to the point where a huge middle class collapsed despite economic recovery after the IMF, due to organized stock price manipulation and securities crimes by large conglomerates such as Samsung Securities and Hyundai Securities.

The Korean people have suffered the damage of being ruined by politics tainted by the corruption and unfairness of the conglomerates, and even though the entire nation has been repeatedly sacrificed by such blatant stock price manipulation, they have continued to fall without any protection from the corrupt government.

8, A Japanese imperialist group that inherits the mad "kamikaze" spirit.

(Sasakawa Ryoich, a first-class murderer in the Pacific War who created the Kamikaze aircraft suicide bombing unit and founded the "Japan Foundation.")



The reason Korea was able to maintain an independent language and culture in Asia and spread ancient advanced civilization to Japan may have been because of its unique geographic location, which prevented it from being annexed by the huge country China. There is a story that says that people in Asia who were chasing the mysteries of the world continued to move toward the rising sun and migrated, and that the place they stopped was the Korean Peninsula.

It is a definite true that Japan was founded by cultural groups who migrated across the Straits in search of mysteries or who were defeated in power struggles on the Korean Peninsula, and more than two thirds of Japanese people are descendants of immigrants who immigrated from Korea.

While Japan was able to build an independent culture without interference from the great country of China, Japan suffered from constant civil strife and brutal wars for a

long time.

As an island nation, Britain was free from the wars of the continent, and Christianity was able to spread, which gave the country some virtuous order.

However, in Japan, where Buddhism and Confucianism, which were spread from Korea, were the entirety of spiritual civilization, a tremendous amount of superstition became a part of daily life.

Religion in Japan is so disorderly that the Unification Church, a cult religion in Korea, grew up in Japan not in Korea.

During the time when the Mongols were sweeping the world, the Mongols, who had swallowed up China and Korea already, attempted to complete their occupation of East Asia by taking over Japan, which had the mysterious country name of "the land of the rising sun"日本 across the sea. When Korea, which was under Mongol rule, and the Mongol army allied to invade Japan, a "sudden storm" struck and caused great damage.

Many ships of the Mongolian-Korean allied forces were damaged and the occupation of Japan was a failure.

The Japanese believed that Japan was protected by a wind sent by the gods, and there are even many religious ceremonies to commemorate this event, so in Japan, where superstitions abound, it is absolutely considered to be protection by the gods.

(The Chinese character 神風 "divine wind" is pronounced "KAMIKAZE" in Japanese.)

Japanese nationalist forces have long plotted and carried out many political conspiracies and terrorist attacks in alliance with pro-Japanese forces in Korea.

They believed that peace and prosperity in Japan could be maintained by opposing peace and cooperation between the South and the North and by trampling and polluting the political order of Korea in alliance with hard-line anti-communist forces in Korea who oppose inter-Korean cooperation.

In "The Art of War," 孫子兵法 a book by the ancient Chinese strategist Sun Tzu, there is a passage that says that "the best strategy is to win without fighting."

The idea that we should seek Japan's peace and interests by opposing South-North cooperation in Korea is something that is shared not only by Japan's far-right nationalist forces, but also by hardliners in the United States who view communism as the devil and believe that peace with communists is dangerous.

If the background of South and North Korea, which had been continuing peaceful dialogue and meetings, being destroyed by pro-Japanese forces who collaborated with Japan to elect presidents who would destroy inter-Korean cooperation and the current situation where war could break out at any time is the work of Japan and pro-Japanese forces, then this is a "Great Success of the **Nippon club.**" (Japan and the alliance of pro-Japanese forces)

Japan enjoyed significant advantages during the three-year Korean War that began in 1950 and ended in 1953, enabling it to join the ranks of advanced countries.

Trump is a terrible thug who thinks it's okay to foment discord between South and North Korea and for both countries to be destroyed in a war if it benefits the U.S., but there are many crazy, evil thugs in this world who only think of themselves, like this extremely evil Netanyahu and Trump.

The Chosun daily news and Dong-A daily news, the two largest media outlets in Korea (both of which have their own newspapers and TV stations), were vicious media outlets that bowed and chanted "Long Live His Majesty the Emperor" during the Japanese occupation.

The reason why Korea was unable to carry out a trial like France did, which executed 10,000 pro-Nazis, was because when the Republic of Korea was founded, the forces that could run the government were almost all pro-Japanese intellectuals, and most Koreans did not have a strong sense of anger toward forces that collaborated with the invading nation like France.

Even after Japan surrendered in World War II, forces that sought to preserve Japan's militaristic imperialist spirit emerged here and there, forming the background for Japan's political and economic circles.

Their leaders who lost the war insisted on carrying on the spirit of the KAMIKAZE (神風 "divine wind,") in which pilots committed suicide by boarding their planes and attacking American battleships.

One of the most representative among them was Sasakawa Ryoichi, who established the Nippon Foundation.

Sasakawa Ryoichi was a man who admired Mussolini and was a Class 1 war criminal after World War II, but was not indicted. He founded 日本財団 the Nippon Foundation in 1962, and his son is the current chairman.

Sasakawa guaranteed that there is nothing Japan cannot do if it continues the kamikaze spirit, and there are so many mad ones around the world who are crazy about blind nationalism like him, including thugl Trump and thug Netanyahu. Sasakawa Ryoichi made a fortune in drugs in China, a business that only the devils do, and was also the chairman of the Gambling Business Association.

His son, who is now the president of the gambling association, has taken over much of what he did.

After the war, Japan tried to improve its external image by doing a lot of overseas PR work through organizations like the Nippon Foundation and fostering PR soldiers. Harvard's Mark Ramseyer, who received supports from Japanese government and organizations, is one of them.

This securities fraud, which occurred in 1999, occurred during the time of Samsung's former chairman, the late Lee Gun-hee, who was suspected of having a Japanese mother and Japanese friends, possibly including Nippon Club.

Nomura Securities, which appears in the case, is one of the powerful sponsors of the Nippon Foundation established by Sasakawa, and among his nephews, there is one who has considerable talent in stock investment, and Sasakawa has been deeply involved in his securities investments.

If the Nippon Foundation invested a lot of money in Korea to foster pro-Japanese forces and create the Nippon Club, it is highly likely that it cooperated with the operations of a conglomerate securities company like Samsung, whose chairman is suspected of having a Japanese mother, so much more friendly with Japan than north Korea.

In still developing countries like Korea, the response to securities crimes is very weak compared to advanced countries like the United States, and even the judiciary often turns a blind eye when powerful groups like conglomerates collude. So should we be telling people not to be born in a country like Korea?

Nomura Securities is a supporting member of the Nippon Foundation, and Sasakawa Ryoichi is very familiar with crimes such as securities operations, as he is deeply involved in the affairs of his nephew, who is very well skilled in securities investment. The Nippon Foundation claims to advocate world peace on the surface, but do you, Chinese scholars, believe the world peace claims of a businessman who made a

fortune in drugs in China, or do you find them ridiculous excuses for a conspiracy? Japanese involvement was suspected when the Japanese perpetrator involved in the KAL 858 bombing committed suicide by taking poison.

9, Did they throw a wild party and film it from behind?

(A villa where sex parties were held, attracting elite groups of politicians, judges, prosecutors, etc.)



The Japanese movie "Flowers and Snakes" has a story about inviting powerful politicians, lawyers, businessmen, and others to a wild sex party and using their weaknesses to carry out endless evil schemes of hell-devil-minded people.

In the movie God Father, there is a scene where a senator is framed for murdering a prostitute in order to manipulate the national politics by the mafia.

Such bizarre conspiracies are actually not uncommon in history. In the gloomy environment of Japan, the bizarre plot in "Flowers and Snakes" has considerable realistic plausibility.

Japanese samurai had a rule of not pouring sake to opponents with their left hand because they might stab their opponents with the right hand while pouring.

A similarly horrifying incident to the one depicted in the film occurred in South Korea, where a construction contractor was reported to have hosted a sex party and invited many elites, including politicians and lawyers.

The critical weakness of the ruling elites who determine the fate of Korea can be stored on a single memory card and used as fatal blackmail material.



This incident is too big to be the work of a single construction worker, and it is suspect that it was orchestrated by a Korean who was instigated by Japanese nationalists alike ultimately for the sake of Japan and pro Japanese groups.

It became known to the world when the wife of a construction contractor, who discovered a videotape of the Deputy Attorney General and the contractor having sex with a woman, sued the woman for adultery.

There was even a media report that previous President Yoon Seok-yeol was invited when he was a civic attorney.

The number of invited individuals was so far beyond the scope of the group, and the scale was so large that it could be considered a group-level event, making it difficult to believe that an ordinary, nameless construction contractor would have learned from an advanced country like Japan in political intrigue and trickery and used it for personal purposes.



It cannot be ruled out that Chung Doo-eon, a relatively conscientious politician who took the lead in announcing that he had attended this party, committed suicide without any reason some time later because he felt threatened by the weaknesses exposed by this party.

Considering that Chung Du-eon's suicide occurred during the period when former President Lee Myong-bak, whom he had been criticizing, was released on parole after a year in prison, it is possible that he was threatened by Lee Myong-bak or that he was caught in some critical situation at the party at Yoon Joong-cheon's villa.

This incident smells ten times stronger of the dry smell of Japanese liquor SAKE than of the smell of Korean kimchi.

In this world of rampant crime, dominated by evil capitalism and nationalist racism, there are many groups of villains who consider it a virtue, political skill, or courage of patriotism to inflict catastrophic and murderous harm on many people for the very small benefit of their own group.

10, The ruling that postponed Trump's prison sentence is a "MESS."

The same terrible situation of the U. S. and south Korea, which elected an evil criminal as president.

The US court's decision to postpone Trump's criminal sentence for breach of trust to allow him to carry out his important duties as president is a case of "absurdity and mess."

If the president is put on trial in a time of great national crisis, such as war, and there is no suitable replacement for someone absolutely necessary for the office of the president, then it would be possible to apply such an empirical rule, but the situation in the United States is not such a great crisis, and in a situation where there are far more replacements than thug Trump, this is a forced ruling that denies the legal obligation of "realistic managementskills."

The American legal community and legal scholars who simply stood by and watched the just court rulings be made should deeply reflect on the declining American society, the enormous damage to the people, and the crisis of riots.

The court's decision, which parroted and legalistically recited the precedents of empirical law that were contrary to the teachings of Christ's justice, is a decision that clearly demonstrates the lack of judicial function, which is a lack of responsibility to deal with a crisis or the ability to recognize special situations.

It is sure that you Chinese and Filipino legal scholars and judges will also lament the collapse of the judiciary, which is being manipulated by a few trash communist cadres and tycoons.

Lord, please help Israel and the Jews to avoid dogmatism and play a pioneering role in improving the destiny of humanity !




